



Vijaybhoomi University is India's first Liberal Professional University, which uses the liberalprofessional framework of education to build a unique curriculum aligned to Industry 4.0. The curriculum facilitates the process of self-discovery in the initial year and thereafter choice of majors and minors to prepare oneself in careers in Business, Music, Data Science, Artificial Intelligence, Law and Design.

Our vision is to nurture holistic, socially responsible, and continuously employable professionals - who can make a positive difference in the world.

The Curriculum and pedagogy revolve around the process of self-discovery and is built on the foundation of liberal framework of education.

At Vijaybhoomi University, teachers think of themselves as enablers and mentors, allowing learners to develop their own learning pathways. The freshmen or first year enables the discovery process by exposing the learners to multiple disciplines across different intelligences of the learner. The sophomore or later years help the learners to opt for courses to meet the requirements of a professional degree that the learner would like to graduate with.

Significant accounting policies and Notes to Accounts annexed to and forming part of the balance sheet as on 31stMarch, 2023 and Income & Expenditure Accounts for the year ended on that date

1. Background :

The University was created by the Act called as Vijaybhoomi University Raigad Act,
 2018 vide notification of Maharashtra State Government dated 29/11/2018

Government of Maharashtra appointed 13/09/2019 as the date on which Vijaybhoomi University, Raigad would become operational vide a notification.

- 2 The University is registered under section 12AA of the Income Tax Act vide the CIT-Exemption vide order dated 30/09/2020
- 3 Vijaybhoomi Education Foundation is a sponsoring body of the University.
- 4 The University has carried out its educational activity by utilizing building and other infrastructure owned by Centre for Development Education, Bangalore and Vijaybhoomi Education Foundation, Mumbai.
- 5 The land on which the building and other infrastructure were constructed is taken on lease from Vijaybhoomi Education Foundation. However, no lease rental has been provided as the quantum of lease rental is still under consideration.
- 6. The building and other infrastructure worth Rs. 13,71,33,045/- was received from Center for Development Education as Corpus Donation in earlier year.



SIGNIFICANT ACCOUNTING POLICIES

(a) The accounts are prepared on historical cost convention in accordance with the generally accepted accounting principles.

(b) Revenue is recognized on accrual basis. The fees receivable from the students is recognized as and when the same is due from the students. The fees received from students for courses which run beyond the end of the financial year and pertain to subsequent years are recognized as advanced from students under 'Other Current Liabilities' and recorded as revenue in the year in which the services are rendered.

(c) Fixed Asset are stated at cost less depreciation. Cost includes freight, duties, taxes, insurance and expenses incidental to acquisition and installation, necessary to bring the asset to the location and condition desired for use by the management.

(d) Depreciation on fixed asset has been provided on written down value method at the rates specified in the Income Tax Act, 1961, and rules made there under.
